Ideal for mounting, framing, bonding and laminating, Avery Dennison transfer tapes offer good conformability and adhesive wet-out.

Applying Transfer Tapes

- 1 Remove the release liner.
- 2 Turn the tape over.
- 3 Apply the tape, adhesive side down, to the application surface.

- Multiple Transfer Tapes and adhesives
- Must order full master of desired slit width
- Custom pattern gum designs are required for new slit widths
- .25” of ungummed area on each roll facilitates handling
