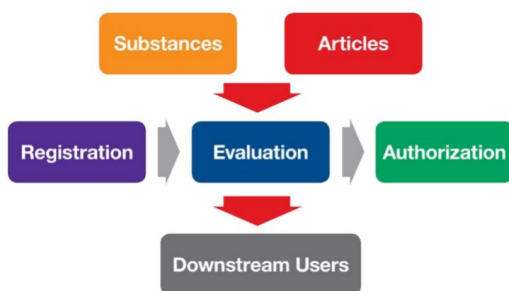

REACH in the EU

REACH (Registration, Evaluation, Authorization, and Restriction of Chemicals) is an EU law designed to place the responsibility on industry to demonstrate safe use of substances, i.e., chemicals. The European Chemicals Agency (ECHA) administers the requirements, and enforcement of REACH is on a country-by-country basis throughout the EU.

Registration

Manufacturers and importers of substances are required to register them, and unregistered substances may not be manufactured or imported above a level of 1000kg per year. Downstream users need to provide information to suppliers on substance use and exposure to support the registration process. In some circumstances, article producers may be subject to registration requirements.

Evaluation and Authorization

REACH sets out a complex process to evaluate substances based on information submitted during the registration process, which may result in a conclusion from the authorities that a substance warrants restriction. Restrictions may limit or ban the manufacture, placing on the market or use of a substance. A substance of very high concern (SVHC) may be added to the Authorization List, and then cannot be placed on the market or used after its sunset date unless an authorization is granted.

Hazard Communication

Under REACH, companies assess the hazards and potential risks presented by a substance, and communicate relevant safety information to downstream users. Safety data sheets are the main communication tool between suppliers and users of substances and mixtures. Effective communication between suppliers and downstream users at all stages in the REACH process ensures that important safety information is provided up and down the supply chain.

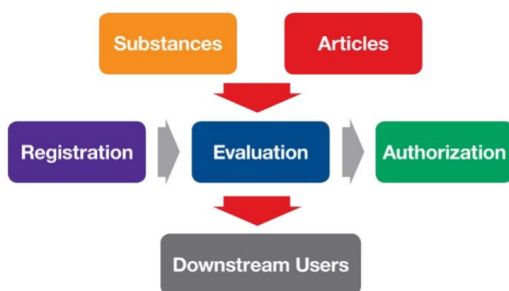

- Ensuring that any substances they place on the market in the EU comply with registration requirements and any applicable restrictions;
- Following the advice on the Safety Data Sheet, making sure their uses are consistent with the identified exposure scenarios, and communicating to suppliers any new information related to hazards;
- Providing Safety Data Sheets to their customers if they are a formulator or refiller; and
- Meeting the requirements for producers of articles if they produce articles in the EU (e.g. communication of SVHC).
